Official Rules and Regulations for Raffle of Boston Celtics Private Luxury Suite (March 12th, 2025 game)

The proceeds from this raffle will benefit the Center for Wildlife (CFW) mission, operations and programming. Tickets will be sold in person at CFW's location via in personal transactions with CFW staff and volunteers. A maximum of 1,000 tickets will be sold with the following pricing structure: 1 ticket for \$25.00, or 5 tickets for \$100.00.

Raffle Rules

- Employees of the Center for Wildlife are not eligible to win the \$14,661.00 Boston Celtics Private Luxury Suite for the March 12th, 2025 game.
- 2. The raffle is open to United States citizens or legal residents of the United States who are over 18 years of age.
- 3. A maximum of 1,000 tickets will be available for purchase.
- 4. No CFW purchase (gift shop, admissions, memberships, etc) or donation is necessary to purchase raffle tickets.
- 5. There is no limit to the number of tickets an individual may purchase.
- 6. Tickets must be filled out in the name of a single individual over the age of 18.
- 7. Tickets are non-refundable.
- 8. Ticket sales at Center for Wildlife, 375 Mountain Rd., Cape Neddick, ME 03902 will cease no later than Friday, January 31st, 2025, at 5:00 PM (EST).
- 9. The winner will be selected at a random drawing on Tuesday, February 4th, 2025 between 9:00 AM and 5:00 PM (EST). Entrants do not need to be present to win. The winner will be notified by phone according to the contact information provided to Center for Wildlife at the time of entry. In the event that a winner cannot be contacted and/or fails to respond within 48 hours of notification, an alternate winner will be selected by CFW. The winner will have 5 business days to accept the prize in writing. If the winner cannot accept the prize within 5 business days or otherwise fails to qualify for the prize, the winner designee will forfeit all rights to the \$14,661.00 Boston Celtics Private Luxury Suite for the March 12, 2025 game, and the same will be awarded to an alternate winner.
- 10. If the winner accepts the \$14,661.00 Boston Celtics Private Luxury Suite for the March 12, 2025 game as the prize, that winner assumes and must pay any local, state and federal taxes when the prize is transferred to the winner. Winnings are subject to regular gambling withholding as stipulated by the IRS and must be paid by the winner when collecting the prize. If the prize is not collected within 15 business days of accepting the prize, then the winner shall forfeit the prize and another winner shall be drawn. Center for Wildlife assumes no responsibility for the winner's tax obligations and suggests the winner contact a tax advisor. This offer is void where prohibited by law and all federal, state and local laws and regulations apply. The prize cannot be exchanged for cash.

By receipt of any prize, winner agrees to release and hold harmless Center for Wildlife and the prize supplier, and the officers, director, employees and agents of each (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the raffle or receipt or use or misuse of any prize.
- 12. Except where prohibited, participation in the raffle constitutes winner's consent to CFW's, sponsor's, prize suppliers' and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration.
- 13. CFW reserves the right to cancel, suspend and/or modify the raffle, or any part of it, if any fraud, technical failures or any other factor beyond CFW's reasonable control impairs the integrity or proper functioning of the raffle, as determined by CFW in its sole discretion. CFW reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the raffle process or to be acting in violation of these Official Rules and Regulations or any other Promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the raffle may be a violation of criminal and civil law, and, should such an attempt be made, CFW reserves the right to seek damages from any such person to the fullest extent permitted by law. CFW failure to enforce any term of these Official Rules and Regulations shall not constitute a waiver of that provision.
- 14. The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by raffle purchasers, printing errors or by any of the programming associated with or utilized in the raffle; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or hard/software; (3) unauthorized human intervention in any part of the raffle process; (4) technical or human error which may occur in the administration of the raffle or the processing of raffle ticket purchases; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from raffle purchaser's participation in the raffle or receipt or use or misuse of any prize. If for any reason a raffle ticket is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, a ticket purchaser's sole remedy is another ticket in the raffle, provided that if it is not possible to award another ticket due to discontinuance of the raffle, or any part of it, for any reason, CFW, at its discretion, may elect to hold a random drawing from among all eligible raffle ticket stubs up to the date of discontinuance for any or all of the prizes offered herein. No more than the stated number of prizes will be awarded. In event that production, technical, seeding, programming or any other reasons cause more than stated number of prizes as set forth in these Official Rules and Regulations to be available and/or claimed CFW reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
- 15. Except where prohibited, raffle purchasers agree that: (1) any and all disputes, claims and causes of action arising out of or connected with this raffle any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate Maine State Court; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this raffle,

but in no event attorneys' fees; and (3) under no circumstances will raffle ticket purchasers be permitted to obtain awards for, and hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-ofpocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and CFW in connection with the raffle, shall be governed by, and construed in accordance with, the laws of the State of Maine, U.S.A. without giving effect to any choice of law or conflict of law rules (whether of the State of Maine or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Maine.
